This Privacy Policy describes the personal data collected or processed when you use Abeyance Cryo Solutions by Abeyatech, LLC's website.

What type of information do we collect?

We receive, collect, and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information. We use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email, password, communications); comments, feedback, product reviews, recommendations, and personal profile.

How and Why do we collect information?

When you conduct a transaction on our website, as part of the process, we collect personal information you give us such as your name, address, and email address.

We collect such Non-personal and Personal Information for the following purposes:

- To provide and operate the Services;
- To provide our Users with ongoing customer assistance and technical support;
- To be able to contact our Visitors and Users with general or personalized service-related notices and promotional messages;
- To create aggregated statistical data and other aggregated and/or inferred Non-personal Information, which we or our business partners may use to provide and improve our respective services; and,
- To comply with any applicable laws and regulations.

How do we store, use, share and disclose information?

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.



How do we communicate with site visitors?

We may contact you to notify you regarding your account, to troubleshoot problems with your account, to resolve a dispute, to collect fees or monies owed, to poll your opinions through surveys or questionnaires, to send updates about our company, or as otherwise necessary to contact you to enforce our User Agreement, applicable national laws, and any agreement we may have with you. For these purposes we may contact you via email, telephone, text messages, and postal mail.

As we continue conducting business, we might sell, buy, restructure, or reorganize businesses or assets. In the event of any sale, merger, restructuring, reorganization, dissolution, or similar event involving our business or assets, your data may be part of the transferred assets.

Dispute Resolution

If you have any complaints or concerns regarding privacy or data use, you should first contact us at [insert email address or physical mailing address]. We will investigate and attempt to resolve complaints and disputes regarding use and disclosure of personal information related to this Privacy Policy. For disputes requiring a more formal process, all disputes shall be submitted to mediation and arbitration.

Mediation. All disputes arising from this Policy shall first proceed to mediation. You may initiate mediation by submitting to us a written request (the "Mediation Request"), which shall identify



dispute. The mediation may occur in person at a location selected by you in Northeast Ohio unless we otherwise unanimously agreed to either a virtual mediation or some other location. The mediator shall be an individual selected by the parties to the dispute (the "Dispute Parties"). If the Dispute Parties are unable to agree on a mediator within thirty (30) days following delivery of the Mediation Request, our General Counsel, or primary attorney for corporate matters if there is no General Counsel, shall select the mediator. Costs and expenses of the mediator shall be borne in proportion by the Dispute Parties in any proportion as the mediator shall decide.

Arbitration. If the Dispute Parties cannot agree to mediation within sixty (60) days of the date of the Mediation Request, or if the Dispute Parties are unable to reach agreement through mediation, then the dispute shall be resolved by arbitration in Northeast, Ohio unless the Dispute Parties can mutually agree to a more convenient location. The arbitration shall proceed with one arbitrator in accordance with the rules of the American Arbitration Association ("AAA") then in effect. Selection of the arbitrator shall occur under the AAA rules. The determination of the arbitrator shall be binding upon all Dispute Parties in accordance with the procedures of the AAA. The cost of the arbitration, including legal fees and costs, shall be borne by the Dispute Parties in any proportion as the arbitrator shall decide.
